



STREAM Terms of Use

The 'Eat Well, Feel Well, Stay Well (STREAM)' online support tool is a website run by the University of Southampton (referred to as the "University" or "we", or "us"), a not-for-profit research institution, which can help make screening and supporting patients at risk of malnutrition easier and quicker.

By using <https://streamsoton.lifeguidewebsites.org> (the "Site"), you confirm that you accept the following terms of use ("Terms of Use") and that you agree to comply with them. By creating an account you indicate that you have read and accepted our Terms of Use:

1. Account terms:

- To use the website, you must be a health care professional who takes part in the Eat Well, Feel Well, Stay Well (STREAM) study. When you register, you need to give your name, a valid email address and describe your role at the practice. By registering on the Site, you confirm that the information you provide is true and accurate.
- You are responsible for the information that you enter, the activity of your account, and for keeping your account and password secure. If you know or think that anyone else knows your password, you must change it straight away. You can do this on the Site.

2. Licence to use the Site:

- If you agree to these Terms of Use, you can use the Site to complete training, do baseline and follow-up questionnaires, and to use it as a guide to screen and treat patients in this study.
- We are the legal owner of all intellectual property rights on the Site, and content unless stated otherwise. These works are protected by copyright laws



and we reserve all such rights.

- The Site must not be used in any way that causes, or may cause, damage to the Site or impairment of the availability or accessibility of it; or in any way which is unlawful, illegal, fraudulent or harmful.

3. User Content:

By using the Site, you are giving consent to have your data collected by the University of Southampton for the Eat Well, Feel Well, Stay Well (STREAM) research study. Your data will be processed as described in the STREAM Privacy Notice.

4. Cookies:

The Site, along with most other major websites, uses cookies. When you enter details into the Site, a cookie is sent to your computer. A cookie is a small file that is saved on your computer which allows the Site to remember some information about you. The Site uses cookies to keep you logged in and to identify your current session.

Our cookies do not contain any information that you enter into the Site or information that would identify who you are. To use the Site you will need to accept our cookies on your internet browser. If you decide to block our cookies, the Site will not work correctly and you will not be able to use it.

5. Limited warranties :

- Although we have taken reasonable efforts to update the information on the Site, we make no representation, warranties or guarantees, whether express or implied, that the content of the Site is accurate, complete or up to date. We provide the Site on an “as-is” basis only.
